

## **VENDOR AGREEMENT**

Dear Colleagues,

Because it is your company who provides our members with product and service excellence, you are invited to participate in the upcoming Florida Laboratory Summit FLS'15 to be held Friday and Saturday, November 13 and 14, 2015, at the Keiser University, 5002 West Waters Avenue Tampa, Florida 33634

This event is the collaborative effort of several of the leading professional laboratory societies and point of care groups in the State. Current groups participating are: **The Central Florida POC Network**, **The Florida Chapter AACC**, **The Florida Chapter of CLMA and the Florida State Society of American Medical Technologists**, (FLSSAMT) and the Florida Society for Clinical Laboratory Science. Attendance for our conferences is typically 90 to 120, yet due to the broader membership base of this event we anticipate this number to be higher with a more interstate reach into S. Most of these attendees register for both days of the conference. Topics will include Point of Care, Core Laboratory and Allied Health subjects.

**Our Key Note Speaker is Dr. James Nichols from Vanderbilt.** Program topics will be targeted for all laboratory and allied healthcare personnel; laboratory directors, supervisors, medical technologists, technicians, physician office managers, staff, allied health program directors, instructors, students; and laboratory consultants.


