DIRECTIONS:

From Columbus (45 miles SE): Take I-71S to Exit 84 (London/Mt. Sterling). Follow State Route 56 for 4 miles to Mt. Sterling. Go to the second traffic light and turn onto Columbus St. Follow for 1 block to the fork at the BP station; turn left on State Rt. 207 for about 4 miles. Turn left onto Cook-Yankeetown Rd. to park entrance. Turn right onto park road; 3 miles to resort.

From Cincinnati (75 miles NE): Take I-71N to Exit 84 (London/Mt. Sterling) and follow the above directions.

From Dayton (55 miles SE): Take St. Rt. 35 Southeast to Washington Court House. Take St. Rt. 62 NE to Washington-Waterloo Rd. For 9 miles to St. Rt. 207. Turn left; follow Rt. 207 for 2 miles to Cook-Yankeetown Rd. Turn right onto Cook-Yankeetown Rd. for about 2 miles to park entrance. Turn right, 3 miles to resort.

Starting Your Lab's Lean Journey

Sue Kozlowski MT (ASCP SBB, DLM and CSSBB(ASQ) (Certified Six Sigma Black Belt) Jane Tester University of Notre Dame, Executive Management and Miami Valley Career Development - Leadership Human Resource Development

Laboratories interested in process improvement are often interested in the lean approach. Many books and articles, however, concentrate on the high-level concepts and it's hard to find information on getting started "from scratch." Sue and Jane will discuss elements that are important for success using a lean approach: Leadership commitment, staffing participation, and lean accountability that fosters sustainment of improvements.

Participants will be able to:

- Assess your lab's readiness for change using a lean approach.
- Identify five main elements of team-based change.
- Describe the three key questions that drive lean sustainability.

Cardiac Enzyme Testing in the Emergency Department – Multi-Marker Approach sponsored by Alere

William E. Maloney, MD, FACEP, Chairman of the Department of Emergency Medicine, Condell Medical Center

Dr. Maloney will address the value of a Multi-Marker Approach to Cardiac Enzyme Testing as it pertains to the assessment of ACS/MI. He will discuss the need for a Sensitive and Specific Methodology to deliver accuracy needed for both Rule/In and Rule/Out of ACS and MI for Patients presenting with Chest Pain to the Emergency Department. Dr. Maloney will cite multiple sources that demonstrate the superior value of a Multiple Marker approach to using Cardiac Markers to provide the ideal tool for aid in diagnosis. Dr. Maloney will address the pitfalls of certain strategies regarding Cardiac Marker testing in the face of possible NSTEMI patients and give real world perspective to the challenge of accurately diagnosing patients on a Rule/In and Rule/Out basis and the overall challenges facing diagnosis of ACS/MI for the benefit of Lab-Based partners who provide testing methodologies for use by Clinicians.

- Identify the role of Multiple Markers in the Assessment of ACS/MI
- Understand the Value of Multiple Markers in the Rule/In versus Rule/Out Diagnostic Dilemma
- Recognize the importance of Sensitivity and Specificity of Cardiac Testing Methods and the relative Positive and Negative Predictive Values needed for an Accurate Diagnostic Tool
